### **Business Arising from Correspondence**

Ring Registry Report - October 2013 - 70 reported. Owners notified.

Robbins and Furst Mt. District Club Letter. They were successful at the Local Council and now have authority from the Yarra Ranges Council to keep and race pigeons after initially being told all pigeons would have to be removed from the premises. There success was based on the "existing use right to keep, breed and train racing pigeons as an ancillary component of the use of the land for the purposes of a dwelling." The decision was based on the fact that pigeons had been there for over thirty years.

<u>Vaccine Trial</u> – Stephen Kearsey advised that Pfizer had agreed to reimburse the cost of the Vaccine Trial and as a result all donations were returned to those that donated. The VHA Members donations collected via annual fees was reimbursed to the VHA with a cheque for \$3920.00 attached.

#### **Liberations**

Liberations had gone well for the races we have flown however we are still being affected by elements with smoke from the NSW fires effecting us. The Secretary added that the late change for basketting for Coonamble (1) was due to a late change in the weather forecast. The Executive felt it was better to do the late change than to proceed with basketting and have the pigeons sitting at the race point in excessive heat

#### **General Business**

It was Moved D.Klopprogge Seconded N.Arathoon that the pigeons in Coonamble (2) be liberated 12 Midday Friday and not Saturday morning. The President put it to the vote and it was <u>Carried 18 For 12 Against 5 Abstained.</u> After the vote, there was lively debate and the President after considering the weather predication re heat at 12 Midday at Coonamble, Vetoed the Vote. The Coonamble pigeons will be released on Saturday Morning. Clock Presentation on Sunday Night.

#### Presentation Day/Night

Neville Arathoon suggested the Presentation Day could be conducted at the refurbished Cranbourne Centre along with their Official Opening and Squeaker Sale. This was referred to the Cranbourne Centre for consideration. This has since been discussed with the Cranbourne Officials by the President and the Secretary and it was unanimously decided that, with the Squeaker Sale, the premises would not be big enough.

Members are requested to consider what sort of Presentation Day/Night they would like have and to forwarded suggestions to the next Delegates Meeting.

#### **Line of Flight Meeting**

The President stated that each stage would be voted on.
