1. <u>VRPU Transport</u> – Confirmation from the Secretary of the VRPU that, after a vote of their membership, they will be transporting with the VHA in 2017.

### Matters Arising from Correspondence

1. <u>VRPU Transport</u>: John Brislin advised the meeting that in his view Paul Brislin taking our trailer to the VRPU accompanied by Cam Murrell, our convoyer, had a large bearing on the VRPU voting to transport with the VHA.

<u>Resolved that</u> the Secretary will write to both persons thanking them for their efforts.

2. <u>ANRPU Donation:-</u> The Secretary advised that the VHA sent an initial donation of \$2000.00 towards the Virus Fighting Fund. This donation is to assist with the early costs. When the overall cost to the pigeon fraternity is known, this matter will be re-visited by the Executive Committee. (Delegates)

## <u>Reports</u>

Ring Registry

1. 40 birds reported and owners notified.

2. The Ring Secretary advised that he has had some pigeons reported and the rings are not recorded on the VHA Ring Registry.

The Secretary stressed that clubs can only sell rings to Full VHA Members and Club Honorary Members who have all their details recorded with the club in question. All rings sold must be forwarded on a list to Ring Registry with full details of the purchasers of the rings. <u>Rings must</u> never be sold as a commercial transaction to a non-member.

#### **General Business**

1. <u>Information Lecture from Dr. Colin Walker:</u> As mention, Dr. Walker conducted an information session re the virus prior to the Delegates Meeting. A special thanks to Colin. The Secretary to send a thank-you letter.

2. <u>Racing 2017:-</u> As a result of the virus, it was moved by G.Jacobs, 2<sup>nd</sup> K. Clark that a vote be conducted:-

(a) Racing for 2017 start at the scheduled starting date of 1<sup>st</sup> July 2017

OR

(b) Racing commence for 2017 at a time to be decided after a vaccine becomes available and the pigeons have been inoculated.

This motion is referred back to the Clubs for discussion and will be voted on at the April Delegates Meeting.

The Secretary advised that 2016 Membership will carry over until the April 2017 Delegates Meeting. <u>The Annual Meeting will be on the same night as the May Delegates Meeting.</u> Annual Membership Fees and Membership Lists must be forwarded to the Treasurer prior to the May 2017 Annual/Delegates Meeting.
