Treasurer's Report-

See attached financials as at end of October, with Bank balances as of 2nd November.

To come out of the bank accounts is \$23K in prize money.

There are some other adjustments with a couple of clubs behind in payments so around \$4k is owing. I have chased up these amounts so we should have them soon. I will continue to hold back prize money payments to these clubs, till they get up to date.

Also to take into consideration is \$7.5K in sponsorship from Godfrey Stevens as this isn't ours really as it will go in prize money.

All SJS Transport accounts are up to date and also Tasmania now totally paid including Wayne Maine down in Tassie. Some Honorariums \$4K approx. still to be paid out also.

In addition, rental income has been paid in advance for 6 months from 1st July so we will receive no income till January. This prepayment was received on 19th June.

We have also allocated away \$300 per race for diplomas and medallions, so around \$5K.

Depending on how we go with racing from hereon if we were to complete the three races with the second 500 and 600 together, we would be looking at least \$14k debit. If we cancel these races, I presume SJS will look for compensation at what level??

Even allowing all this, the bank Balance of \$34k plus online Account \$80K covers all, including the provisions we hold from Bayswater donation and sale 2022 (Total \$40K).

- VHA presentation Monday the 13th of January at Sandown greyhounds.
- It was decided not to have an online pigeon auction and now to be replaced with general squeaker sale. Sunday the 19th of January at Notting Hill. Top 30 in the averages will be invited, plus others wanting to donate. All proceeds go to the VHA transport 2025.
- Remembrance Day: Thank you to G & E Sheean and Sam Spiliopoulos for assisting and liberating birds at the Shrine.
- The Executive Officers were given authority to grant payment of prize money for the 500-mile race. Moved P Bryant Sec. A Demidowski Carried
- A Demidowski stated the race schedule as it is an issue.
- J Weaver asked why the 300 comeback was changed by the executive and that he believed that the rules were broken in doing so. Steve Brown stated that under rule 5 (h) the Executive Officers could vary the race schedule and that the voting was 6 to 1 in favour of the change. After a long discussion and many opinions, there was no resolution.
- J Van Beers thanked S Spiliopoulos for his un waiving service as transporter.
- J Weaver enquired about the unit donated by G Stevens it was stated that A Spiliopoulos is going to pick up the unit and check all aspects of it.
- A Spiliopoulos raised weather concerns for the 500- & 600 races. After much discussion amongst the delegates it was moved J Weaver Sec. P Bryant that we only have 1 x 500 mile race with no 600 and basket Saturday night for a Tuesday the 19th liberation of the Coonamble race. Carried. It was also Moved J Weaver Sec. N Stone that the 500 be conducted as a national race, if permission can be obtained from the National Committee to alter from 600 to 500 miles. Carried.
